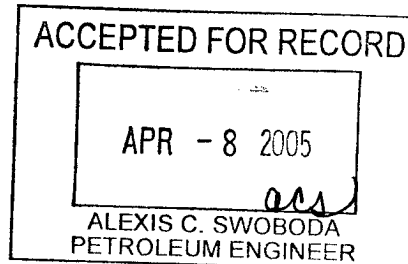

Cement with 450 sx Permian Basin Critical Zone + 1/4 pps flocele and 200sx Premium Plus + 2% CaCl. WOC 27 hrs. Test casing to 1000 psi. Drill 7-7/8" hole to 7590'. Ran 184 jts 5-1/2" 15.5#, J-55, & L-80 LTC casing set @ 7590'. Cement with 860 sx Premium Plus + 2% Zoneseal + Nitrogen. TOC by Temp Survey @ 4314' GL. Released Rig @ 1:00 pm on 3/23/05. Prep for completion.
