Work commenced on 2-08-2012. RU Vac truck to casing, PU 4 3/4 inch bit, bit sub - TIH picking up 151 jts of 2 7/8 inch N-80 8rd tbg to tag cement at 5020 feet. RU power swivel - Drill Out cement and DV tool, RB swivel. Continue picking up tbg to tag PBDT at 7570 feet (229 jts). Circulated well clean w/ 270 bbls of 2% KCl water. RIH w/CBL/CCL/GR from PBDT (7567 feet) to surface w/ 1000 psig on well, shows good cement bond to 1600 feet.
