Stage 1: Lead = 454 sx of 35:65:6 PzC (YLD 2 WT 12.5), Tail = 200 sx of Class C (YLD 1.34 WT 14.8) 3500'-1600'

Stage 2: Lead = 360 sx of 35:65:6 PzC (YLD 2 WT 12.5), Tail = 200 sx of Class C (YLD 1.34 WT 14.8) 1600'-0'

Excess is 100%

DV tool will be placed at approx. 1600' if no more losses are encountered, if more losses are encountered then a Stage Packer

Tool will be used instead and set at approx. 1600'.
