As the current operator you are required to: **Prove the production casing integrity from no more than 100 feet above the perforations or open hole with a documented minimum pressure test of 500psig for 30 minutes**, and do one of the following

A) Return the well to production or beneficial use, within 30 days or by 9/20/12

Contact BLM office at least 24 hours prior to the scheduled Casing Integrity Test. For wells in Eddy County, 575-361-2822; or Paul Swartz at 575-234-5985, Jerry Blakley at 575-234-5994

#### **Determine the operational value of the well.**

- a. Within 5 days of well being placed back on production notify this office by Sundry.
- b. Within 30 days of well being placed on production provide documentation that well is producing in paying quantities.
