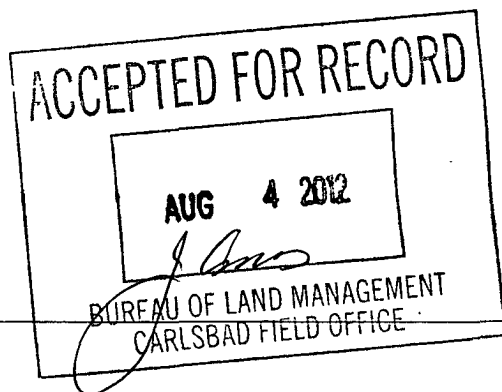
Pursuant to NOV and subsequent approval of work by Jennifer Van Curen of BLM on 7/30/2012, below is summation of work performed:

- 1) Graded area pulling old surface soil to the center and leveled
- 2) Placed liner and graded 12 plus inches of clean dirt/caliche onto pit area
- 3) Built small berm to surround newly placed dirt
- 4) reduced size of caliche pad
- 5) cleaned up trash and other equipment
- 6) broadcasted number 3 mix seed to pit area and all disturbed areas

Abandoned road

- 1) leveled and changed appearance of being a road
- 2) broadcasted number 3 mix seed to road area
