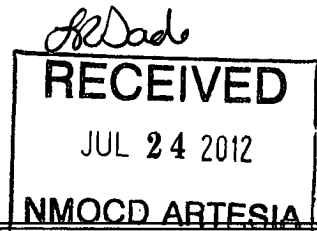

Mixed @ 14.8 #/g w/1.34 yd. Plug down @ 11:00 AM 05/16/12. Did not circ cement. Slow rate lift pressure @ 200# @ 2.5 BPM. WOC. Ran temp survey indicating TOC @ 106'. RIH with 1" pipe. Tag at 110'. Cmt 1st plug with 112 sks Class C w/1% CaCl₂. Mixed @ 14.8 #/g w/1.34 yd. Circ 29 sks cement to pit. WOC 18 hrs. At 10:45 AM 05/17/12, tested csg & BOPE to 1250# for 30 mins, held OK. Drilled out with 12 1/4" bit.
