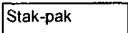
Ledger for Site Diagram

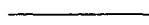

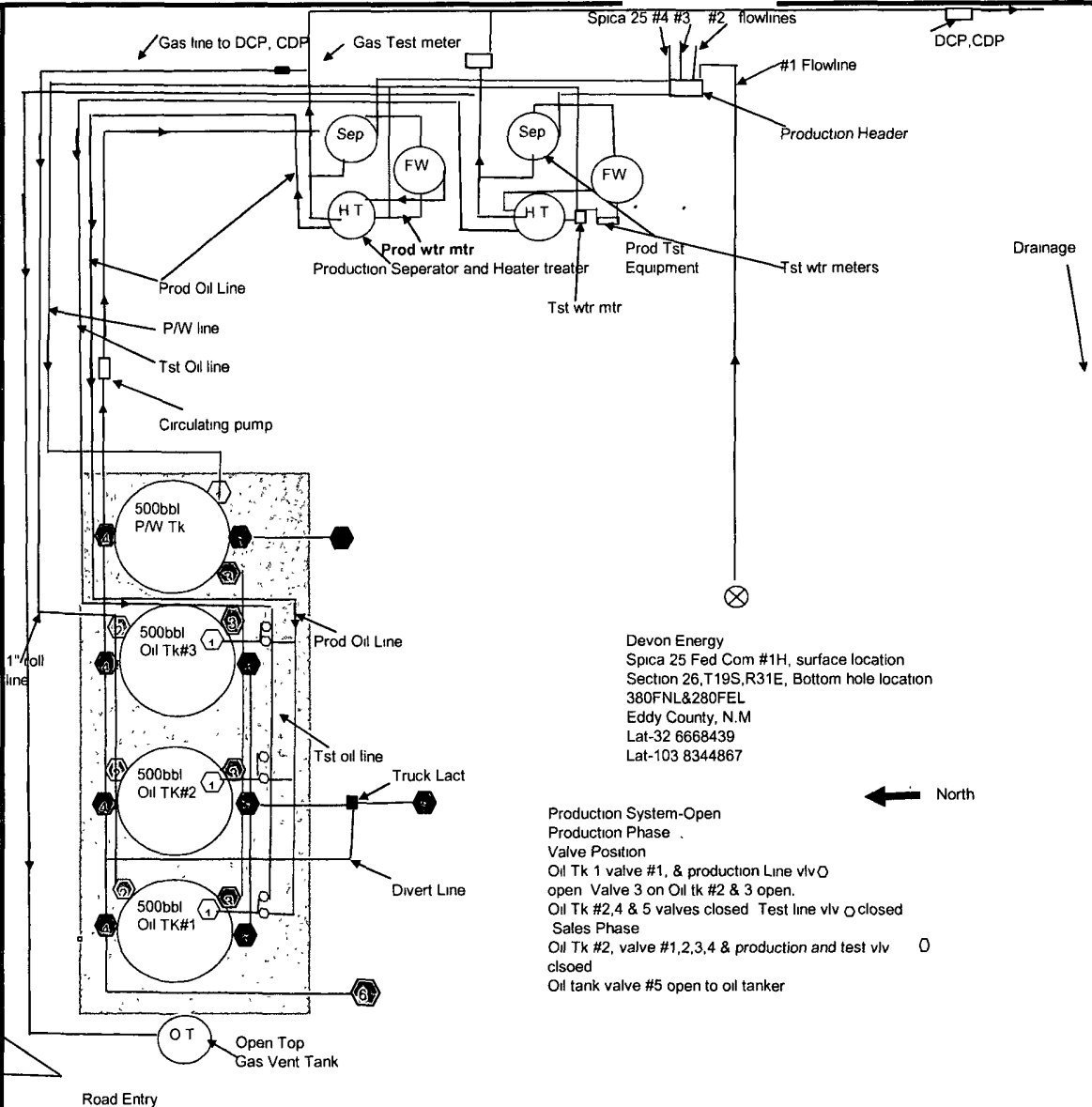
