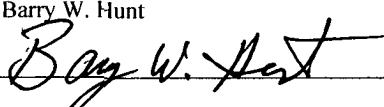

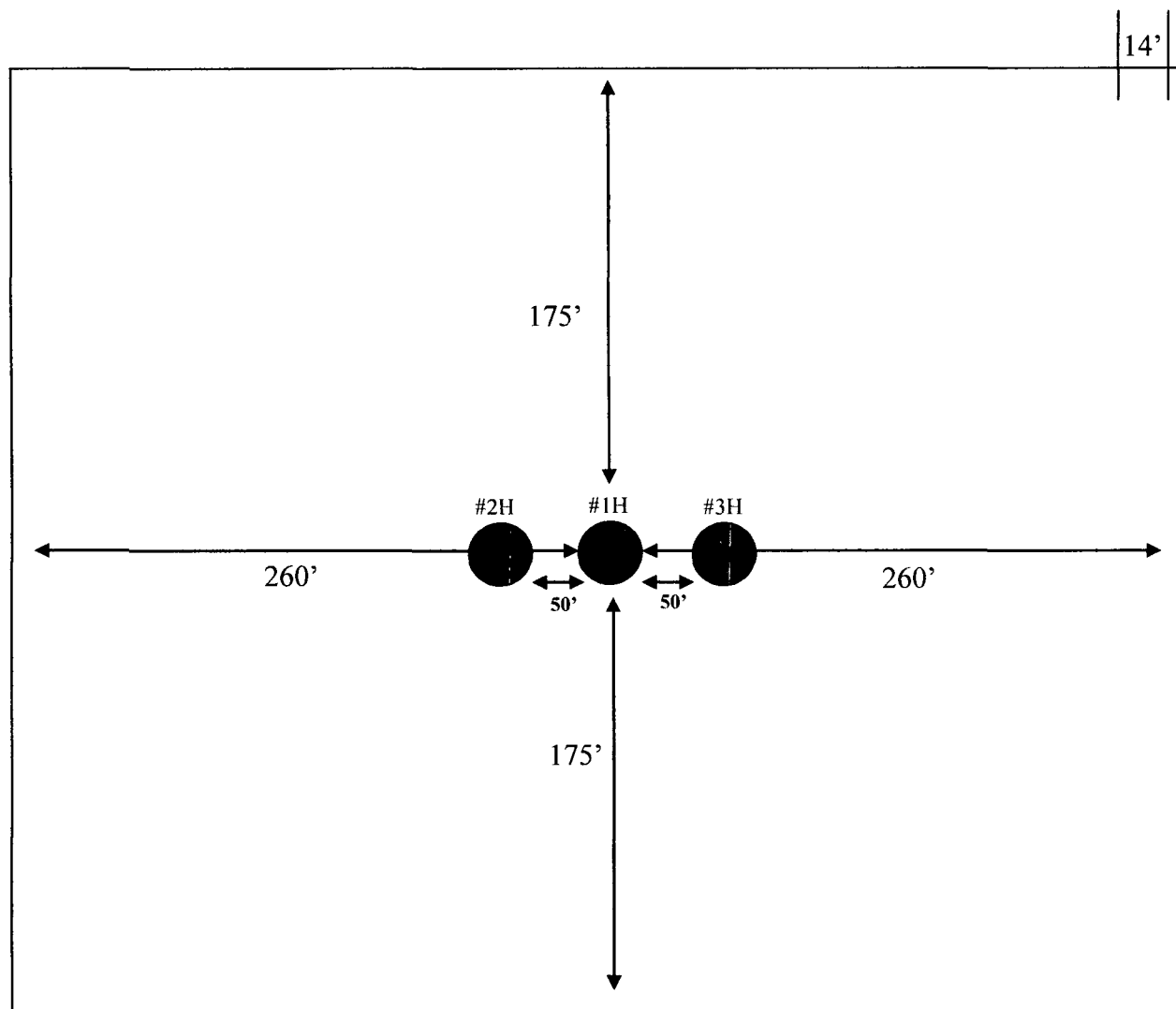

V-DOOR EAST



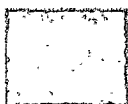
