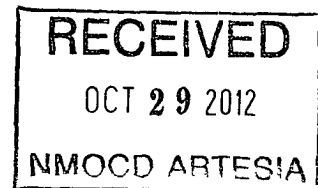
To lay a 3" buried poly flex flow line from the BFDU #59 located 2035.5 FSL & 1272.3' FWL Section 27, T21S-R27E and the BFDU #60 located 2050' FSL & 1320' FWL Section 27, T20S-R28E to the BFDU #48 located in the NE/4SE/4 of Section 28, T20S-R28E and to the BFDU #47 located in the NW/4SE/4 of Section 28, T20S-R28E.

This line is expected to carry 200 BOPD, 1 MMCFD, and 1000 BWPD @ 100 PSI.

The spacing for said line is 30 feet wide by 3,553.53 feet (215.37 rods), consisting of 2.447 acres.
