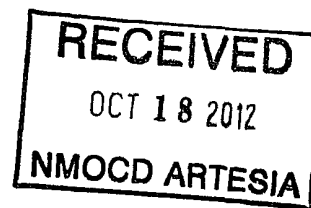

Followed w/150 sks Class C w/additives. Mixed @ 14.8/g w/1.34 yd. Tail with 150 sks Class C w/2% CaCl2. Mixed @ 14.8 #/g w/ 1.34 yd. Plug down @ 2:45 AM 10/08/12. Did not circ cement. Lift pressure @ 82# @ 2.8 BPM. Ran temp survey indicating TOC @ 135'. RIH with 1" pipe. Tag at 143'. Ran 1" pipe in 5 stages with 159 sks Class C w/6% CaCl2. Mixed @ 14.8#/g w/1.34 yd. Circ 8 sks cement to pit. WOC 18 hrs. At 11:30 PM 10/09/12, tested BOPE & csg to 1250# for 30 minutes, held OK. Drilled out with 12 1/4" bit.
