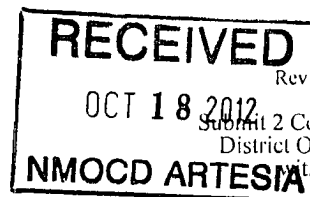

Describe Cause of Problem and Remedial Action Taken.* Lost supply pressure to dump on KO for Walt Canyon #6, and sent water to heater treater. Water over came heater and was sent to oil tank. Tank over ran from incoming volume. Alarm system failed. All Fluids were held within the berm. Contributing wells were shut in and vacuum trucks were dispatched to the area to recover standing fluid.		
Describe Area Affected and Cleanup Action Taken.* An approximate size of 40' x 150' was impacted. The impacted area is located around the tanks knockout, heater and between the flowlines. Soil from the pooling areas was excavated and disposed of at an NMOC D approved facility. Vertical and horizontal delineation samples will taken and analysis ran for TPH and BTEX once all contaminated material has been removed. <b>Depth to Ground Water: &gt;100' (approx. 585', per New Mexico State Engineers Office); Wellhead Protection Area: No; Distance to Surface Water Body: &gt;1000'; SITE RANKING IS 0.</b>
