Spud well on 10/27/12. Drilled 12-1/4" hole to 430'. Landed 8-5/8" 24# J-55 csg @ 424'. Cmted w/300 sx (402 cf) "C" cmt w/2% Cacl2 & 0.25# CF. Circ 29 sx cmt to surface. On 10/29/12, PT 8-5/8" csg to 600 psi for 30 min-OK.

Drilled 7-7/8" hole from 8-5/8" csg shoe to MD4425' on 11/4/12. Ran open hole logs. On 11/4/12, landed 5-1/2" 17# J-55 csg @ MD4422'. Cmted lead w/250 sx (475 cf) 35/65 poz "C" cmt w/1/4#/sx CF, 5% salt, 5# LCM-1 & 0.3% R-3. Tailed w/625 sx (831 cf) "C" cmt w/0.2% CD-32, 0.25#/sx CF, 0.25% R-3. Circ 156 sx cmt to pit. Released drilling rig on 11/5/12. Plan to pressure test 5-1/2" csg before completion operations.
