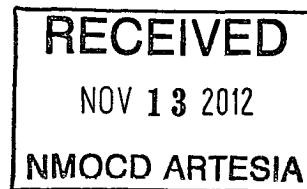

Due to hole conditions we were unsuccessful in running our open hole packer assembly to TD. SM Energy is requesting the permission to change the scope of our completion design to a 5-1/2" long string casing design. We will run 5-1/2" 17# P-110 LTC casing from TD to surface. The cement will be pumped in one stage and the slurries are as follows:

Lead: 1,335 sks
Density: 11.6 ppg
Yield: 2.62 cf/sk
(50:50:10) Pos (Fly Ash) Class H Cement 0.45% SMS + 5 % Salt + 0.125 lb/sk Cello Flake
Excess calculated to 75% excess of caliper.
