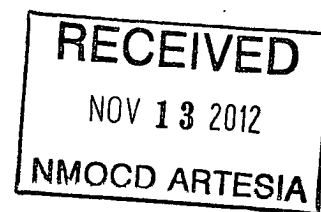

Circ 83 sks cement to pit. WOC 18 hrs. At 6:45 AM 10/20/12, tested csg to 1250# for 30 mins, held OK. Drilled out with 12 1/4" bit.
