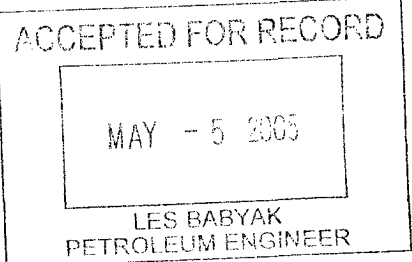

WOC then weld on and test well head and BOP @ 1,000 psi high and 250 psi low test OK. Test casing to 1,500 psi for 30 min test OK. WOC 18 hrs.
