Cement with 450 sx Permian Basin Critical Zone + 1/4 pps flocele + 1 pps gilsonite & 200 sx Premium Plus + 2% CaCl and 175 sx Premium Plus + 2% CaCl. WOC 24 hrs. Test casing to 1000 psi f/30 min. held ok. Drill 7-7/8" hole to 7570'. Ran 145 jts 5-1/2", 15.5# J-55, LTC & 35 jts 17# J-55 LTC casing set @ 7562'. Cement with 800 sx Premium Plus + 2% Zone Seal 2000 with nitrogen. TOC by Temp Survey 4620'.
