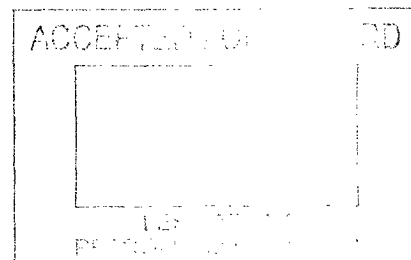

5/24/05 Ran in 81 jts 5 1/2", 15.5#, J-55 LT&C csg and set @ 3618'. Cmt lead w/ 200 sx CI C, tail w/ 424 sx (60:40) CI C; circ 9 sx to pits. Release rig.
