Tailed in with 200 sx "C" with 2% CaCl (yld 1.33, wt 14.8). WOC. Cement circulated to surface. Tested casing to 1200 psi for 30 min. WOC 41 hrs 25 min. Reduced hole to 8-3/4" and resumed drilling.
