NOTICE OF VIOLATION - Inspection

Dear Operator:

Comments on Inspection: Location needs attention. Equipment OK. Area north of wellhead heavily contaminated from what appears to be a repaired flowline leak. Replaced section of steel flowline crosses contamination area at nearly upper apex of downhill flow path. Flow path extends approximately 30 feet through pasture to wellhead area then turns east continuing the general downhill movement towards a natural draw. Remediation required. Contact NMOCD District 2 Environmental Compliance Officer to discuss remediation requirements.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
