Cement with 360 sx Permian Basin Critical Zone + 10 pps gilsonite + 1/4 pps flocele & 200 sx Premium Plus W/2% CaCl2. Circulate & WOC 32 hrs. Test casing to 1000 psi f/30 min. held ok. Drill 11" hole to 2245'. Drilled 7-7/8" hole to 7590'. Ran 154 jts 5-1/2" 15.5#, J-55 LTC & 31jts 5-1/2" 17#, J-55 LTC casing set @ 7586'. Cement with 615 sx Premium Plus + 2% Zone Seal 2000 w/Nitrogen. TOC by Temp Survey 4660'.
