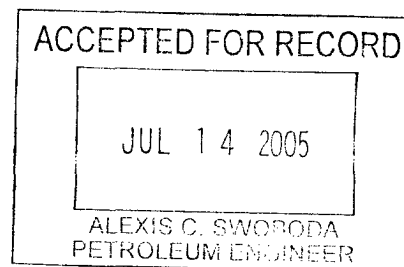
13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof.

7/5/05 Set 5-1/2" 17# CIBP at 6570' with 35' cement on top. TOC at 5826' CBL. Perforate Wolfcamp 6104'-6342' for a total of 87 holes.

Recompletion unsuccessful, plan to plug and abandon the well.
