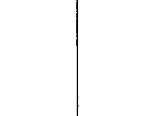

Sight Security Diagram

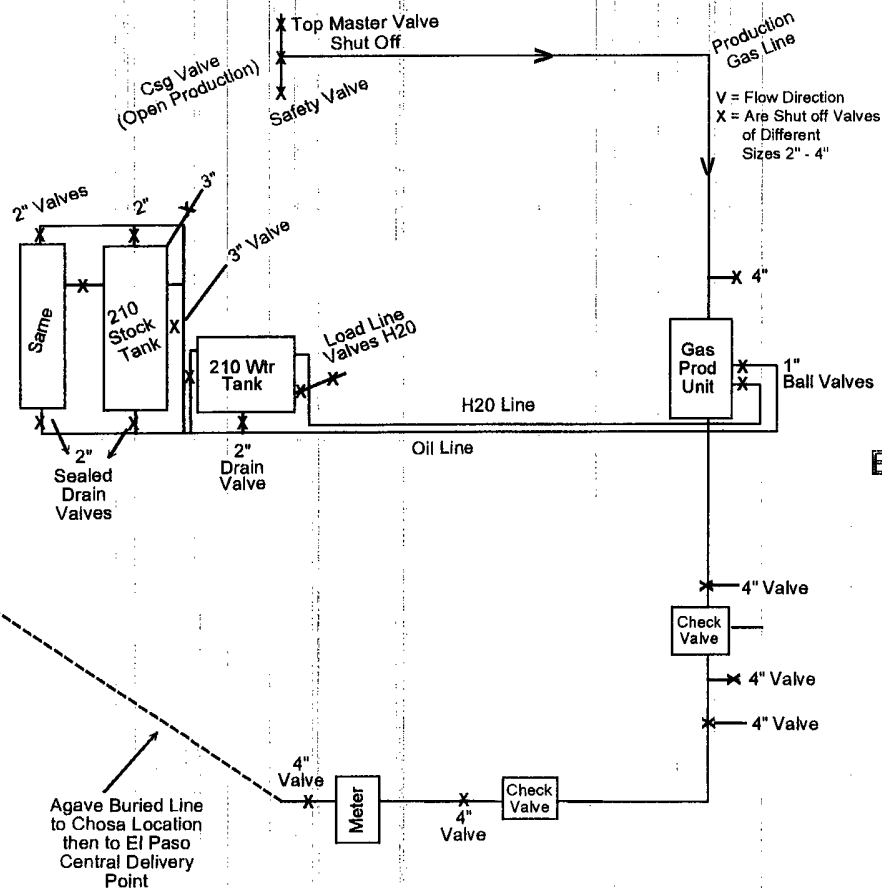
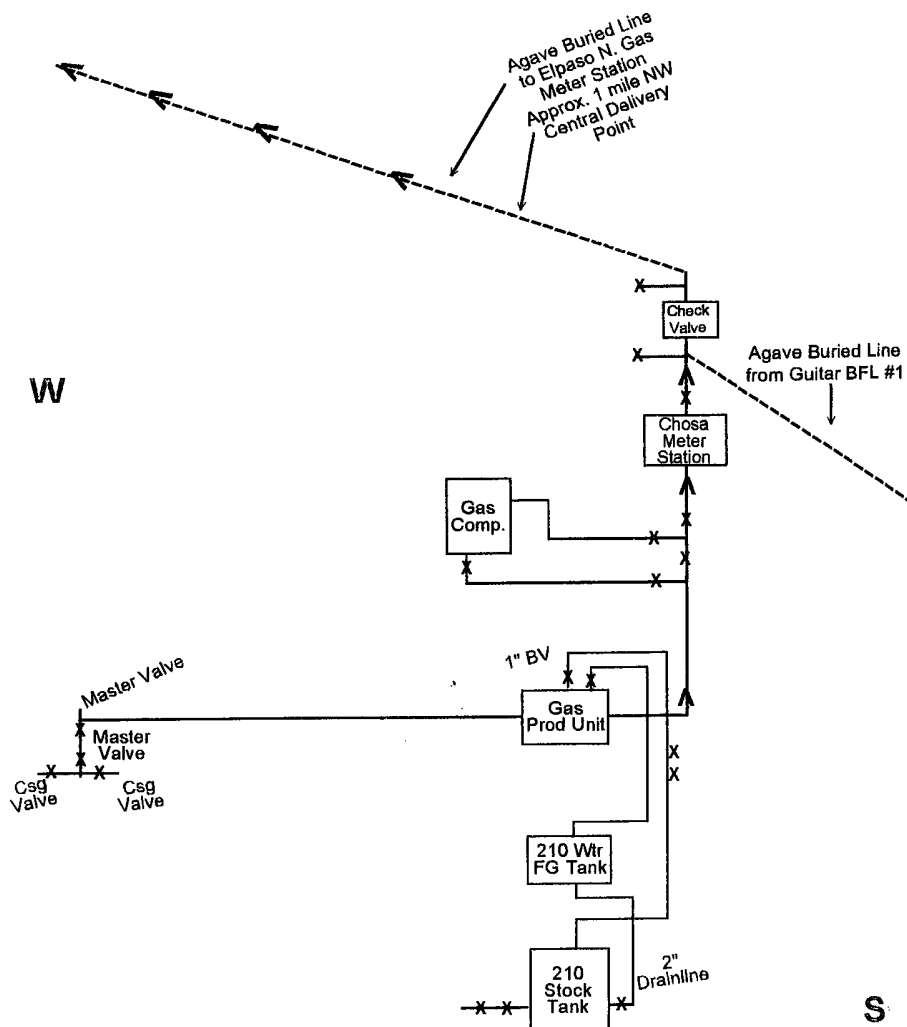

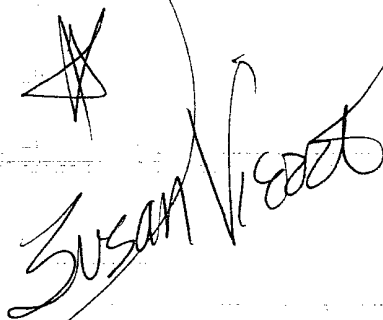
