Comments on Inspection: Tank battery on site (Todd 23 BC Federal Battlery) has berm made up of mostly contaminated soils and caliche material on south and west sides. Gravel inside tank battery fence and berm covers contaminated soils. Pump and sump area outside northwest corner of tank battery berm has gravel covering contaminated soil. Run off from this pump and sump area has run off into pasture to the west approximately 50 feet. Remediation Required. Contact NMOCD District 2 Environmental Compliance Officer to discuss remediation requirements.
