Surface Damage/Restoration

Comments on Inspection: Well listed as idle well 3-16-04. Last reported production was 10-1-00 (59 months). No Action Taken To bring Well into Compliance. No pumping equipment or other production equipment on location.

Flow lines south of this well have leaked and been repaired. Pasture has been impacted from initial leak and runoff over area approximately 125 feet by 50 feet. Remediation required.

Contact NMOCD District 2 Environmental Compliance Officer with site ranking and remediation work plan.

Notify NMOCD District 2 Office 48 hours prior to any remediation work or taking samples where results that may be submitted to OCD.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
