Cmted w/lead 300 sx (570 cf) 35:65 POZ "C" cmt W/5% salt, 0.55% R-3, 5# LCM-1, & 1/4# super flake & tailed w/600 sx (798 cf) cl "C" cmt w/0.2% CD-32, 0.25% R-3 & 0.25# Cello Flake. Circ 283 sx cmt to pit. Released drilling rig on 11/16/12. Plan to pressure test 5-1/2" csg during completion operations.
