Mewbourne Oil Company received an approved APD for the above caption well. After further review, during drilling operations MOC would like to drill the 26" hole inside 30" conductor to 300' with flow nipple. MOC will run 20" casing to 300' and after cementing the 20", install diverter system. During drilling operations, MOC will drill 17 1/2" hole to 1200' with diverter system. After cementing the 13 3/8" casing, MOC would like to waive the third party testing of the 13 3/8" BOPE and casing. Since this section is 2000 psi rating, MOC would like to test BOPE to 70% of casing rating using rig equipment. If you have any questions, please call Terry Burke at 505-393-5905.
