

Mixed @ 15.6 #/g w/1.21 yd. Plug down @ 10:30 PM 11/30/12. Circ 125 sks cement to pit. WOC 18 hrs. At 7:15 PM. 12/02/12, tested csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.
