Yates Petroleum Corporation wishes to amend the Surface Use Plan for the captioned to include the construction of a 320' x 320' x 11' deep fresh water reservoir to be used for the drilling and fracking operations for the Bennett Federal #3H. The frac reservoir will be located approximately 1800' to the northeast of the Bennett Federal #3H. The frac pond will use one half of the reclaimed Bennett Federal #1 well location and a portion of the reclaimed access road the the Bennett Federal #1 well. On the south edge of the frac pond we will construct a 12' wide road with ramps and a turn around for the trucks after unloading. Please note attached survey plats showing the location and access road to the freshwater reservoir.


