

Describe Area Affected and Cleanup Action Taken.* An approximate area of 40' X 100'. Impacted soils to be scraped up and taken to an NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX. Sampling for chlorides will be done for documentation purposes. If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted. Depth to Ground Water: >100' (approximately 116', Section 17-T19S-R26E, per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on recovered amounts of produced water, impacted soils excavated/hailed, enclosed analytical results and a liner being placed over the impacted area, Yates Petroleum Corporation requests closure.
