

9/23/05 Tagged at 3978'. Perforated at 2012'. Squeezed 35 sx cement at 1730'. WOC. Tagged at 1887'. Perforated at 1152'. Squeezed 45 sx cement at 865'.
9/26/05 Tagged at 985'. Perforate at 257'. Squeezed with 115 sx cement to surface leaving casing full. Cut off wellhead and anchors. Installed dry hole marker. **WELL IS PLUGGED AND ABANDONED. FINAL REPORT.**
