

2-1-2013: Picked up 5-1/2 x 3-1/2 10k nickel coated arrow set packer with on/off tool and pump in plug in place. R.I.H with packer and 380 joints 3-1/2 9.3# L-80 plastic coated tubing. Set packer at 12,532.89 ft. Released on/off tool and circulated hole with 330 bbls packer fluid with corrosion inhibitor. Latched back on to on/off tool and pressured up casing to 550 psi and ran pressure recorder chart for 40 minutes casing tested good.

2-7-2013: Met with Richard Inge with N.M.O.C.D on location at 9:00am. BLM rep not present. Rigged up L AND E kill truck and pressure up casing to 550 psi. Ran pressure recorder chart for 30 minutes well tested good. Sent copy of chart and State Inspection sheet to Paul Swartz with the B.L.M.
