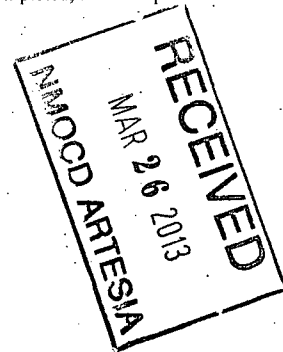

Tested BOPE to 3000# & annular to 1500#. At 7:15 A.M. 02/22/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.
