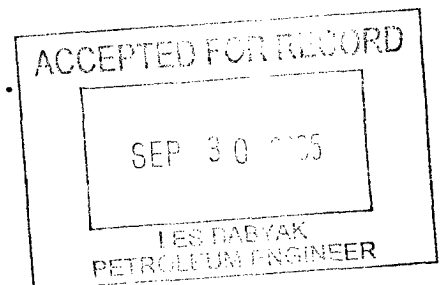

RIH w/ 5 1/2" CIBP set at 7535'.
8/02/05 Rig down, move out.
9/12/05 MIRU to begin horizontal drilling operations.
9/14/05 Tagged CIBP @ 7535'.
9/15/05 Set whipstock, window at 7520'. Begin drilling lateral.
