Spud well on 3/29/13. Drilled 12-1/4" hole to 500'. Landed 8-5/8" 24# J-55 csg @ 495'. Cmted w/375 sx (506 cf) "C" cmt w/2% Cacl2 & 0.25# CF. Circ 188 sx cmt to surface. On 3/31/13, PT 8-5/8" csg to 600 psi for 30 min-OK.

Drilled 7-7/8" hole from 8-5/8" csg shoe to 5415' on 4/3/13. Ran open hole logs. On 4/4/13, landed 5-1/2" 17# J-55 csg @ 5410'. Cmted lead w/350 sx (666 cf) 35/65 poz "C" gel cmt w/0.125#/sx CF, 5% salt, 5# LCM-1 & 0.2% R-3. Tailed w/650 sx (865 cf) "C" cmt w/0.25#/sx CF & 0.6% R-3. Circ 173 sx cmt to pit. Released drilling rig on 4/5/13. Plan to pressure test the 5-1/2" csg before completion operations.
