With the BLM's approval, Apache Corp would like to secure the Raven Fed Com #11H well at the 9-5/8" csg seat & then move Basic #44 off of the well. For safety reasons, Apache will have the pad evaluated for structural support integrity prior to moving a drlg rig back in & resuming operations. At this time we estimate that this process will take 3 or 4 weeks.

To secure the well after cmtg the 9-5/8" csg, a 13-5/8" 3M x 11" 5M ?B? section with a valve will be installed & tested on the existing ?A? section. Then a cap will be installed on top of the ?B? section This cap will be left in place until drlg operations can be resumed.
