BOPCO, L.P. requests to make the following changes to the above captioned well:

Deepen the 7-7/8" pilot hole to a depth of 11,000'. This will take us to the base of the 2nd Bone Spring at 10,960' plus 40' of rat hole for logging tools. A Smith Trackmaster openhole whipstock will not be used. A balanced cement plug will be pumped and set from 11,000' - 10,500'. Final cement volumes will be based on no less than 30% over gauge hole. This plug will be Class "H" + additives @ 15.6 ppg, 1.18 cu ft/sk, 5.219 gal H20/sk.

A second balanced cement plug will be set from 9,079' - 8,579' with a planned KOP of 8,979'. Final cement volumes will be based on no less than 30% over gauge hole. This plug will be Class "H" + additives @ 17.5 ppg, 0.94 cu ft/sk, 3.363 gal H20/sk.
