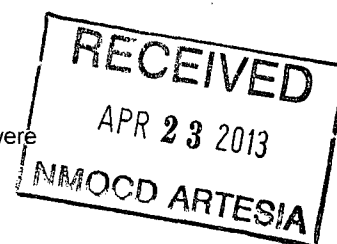
BOPCO, LP respectfully submits this sundry for interim reclamation on the subject well.
