BOPCO, L.P. requests permission to rig down the Latshaw Rig #18 and release it after running and cementing the 13-3/8" 1st intermediate casing string on the Big Eddy Unit #250H on April 20th, 2013. BOPCO, L.P. will install the 13-5/8" 5,000 psi B section wellhead, the 11" 5,000 psi C section wellhead and a 5,000 psi 11" blind flange on top of the C section. The wellhead will be rigged up with a gauge to monitor pressure and wellbore integrity. BOPCO, L.P. plans to move Latshaw #18 over to the Big Eddy Unit #265H. The BLM has granted an approved APD for the Big Eddy Unit #265H. BOPCO, L.P. plans to move back to and rig up Latshaw Rig #18 after LPC timing restrictions have been lifted. BOPCO, L.P. will notify the BLM when moving the Latshaw Rig #18 off of the Big Eddy Unit #250H location and when the Latshaw Rig #18 moves back to the Big Eddy Unit #250H location. Upon return to the Big Eddy Unit #250H, the Latshaw Rig #18 will be rigged up in compliance with the approved
