

Steel flow line from discharge water pump developed leak. Valves were isolated from main waterline, repairs made. Vacuum trucks called.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 30' X 30' (outside of production pad). Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 10) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. **Depth to Ground Water: 50-99' (90', Section 28, T25S-R28E, NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: > 1000', SITE RANKING IS 10.**
