BOPCO, L.P. requests to make the below changes to the above captioned well:

Change the 9-5/8", 40#, N-80, LTC 2nd intermediate casing cement job from one stage to two stages. An ECP and DV tool will be placed at approximately 2,723' at the top of the Capitan Reef to increase chances of getting cement to surface on second stage. Final placement will be in a gauge section of hole as determined by a caliper log. Stage 1 Primary - 710 sks Halcem "C" + additives (13.5 ppg, 1.75 cu.ft./sk). Stage 2 Lead - 530 sks Econocem "C" + additives (12.9 ppg, 1.85 cu.ft./sk). Stage 2 Tail - 100 sks Halcem "C" + additives (14.8 ppg, 1.33 cu.ft./sk). Final cement volumes will be based on 30% excess over caliper log.
