Apache Corporation would like to request a variance from the approved interim reclamation. The approved IR Plat suggested that we take 15' from the west edge and 60' from the south edge. The IR also stated that the location would be built to the specs of 270' x 225'. The actual location is 222' x 195'. The road comes in on the northwest corner which will affect the downsize area. This location is also shared with Linn Energy. Apache Corporation would like to take 78' to 85' to each anchor on the south edge of the pad. We installed a temporary berm after the reportable release. Once we have downsized this location another berm will be placed in the same area to protect the arche sites in the area. Attached you will find the site maps and a copy of the interim reclamation plat.


INTERIM RECLAMATION LAYOUT




V Door

The original pad measures 265 FT x 222 FT.


The downsized pad will measure 195 FT x 222 FT.
