5/3/13: Ran 9 5/8" casing to 4638. Received approval from BLM for change of plans for setting of casing string
5/4/13: Stage 1: pmped 210 sxs cmt @ 1.33 yield. Displaced w/60 bbls water followed by 288 bbls of brine. Bump plug w/730 psi; equipment held. PU to 2315 psi to set pkr. Set DV tool. Circulate 21 sxs cmt to surface. Stage 2: pumped 20 bbls gel spacer, pumped 1600 sxs Econocem C cmt @ 1.88 yield. Displace w/307 bbls brine. Bump plug & psi/up to 2900 psi to close stage tool. Equipment held. No cement to surface.
5/5/13: WOC. Ran temp survey. TOC@1010. Test casing to 1500 psi for 30 minutes. No psi loss
5/6/13: Ran CBL w/psi and without psi. Test 13 3/8 x 9 5/8 casing to 1000 psi for 30 minutes. Held. Drilled out the 9 5/8" casing shoe. Performed FIT to 11.6ppg EMW as required and continued to drill as planned.
