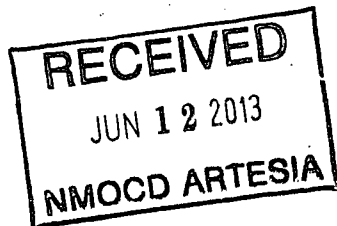

In response to BLM's letter dated April 22, 2013, Strata Production Company requests an exemption from Interim Reclamation Procedures for the above referenced well since the location is inside the Potash Enclave and subject to be used as a drilling island.

There is no reason to reduce the location size if multiple wells may be drilled off the location.

If it is determined that the pad will not "host" additional wells, the pad will then be downsized.
