After running the 8-5/8" surface casing, a 11" BOP/BOPE system with a minimum rating of 2M will be installed, used, maintained and tested as per Onshore Order 2. In addition to the high pressure test, a low pressure (250-300 psig) test will be performed. Please see attached Diagram A.


