Spud well on 10/31/13. Drilled 11" hole to 527'. Landed 8-5/8" 24# J-55 csg @ 527'. Cmted w/325 sx (437 cf) "C" cmt w/2% CaCl2, 0.005# static free, & 0.25# CF. Circ 84 sx cmt to surface. On 11/2/13, PT 8-5/8" csg to 600 psi for 30 min-OK.

Drilled 7-7/8" hole from 8-5/8" csg shoe to 5368' on 11/7/13. On 11/7/13, landed 5-1/2" 17# J-55 csg @ 5363'. Cmted lead w/350 sx (665 cf) 35/65 poz "C" cmt w/5% salt, 6% gel, 2% R-3, & 0.125# cello flake. Tailed w/625 sx (825 cf) "C" cmt w/0.5% PF-13, 2% PF-167, 0.2% PF-65, & 0.125# PF-29. Circ 125 sx cmt to pit. Ran cased hole logs. Released drilling rig on 11/7/13. We plan to pressure test the 5-1/2" csg before completion operations.
