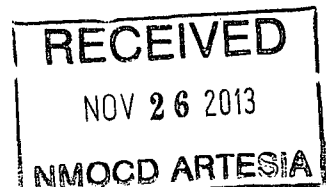

5-5-2013 MI&RU. TOH with pump and rods. Flush tubing. Drop standing valve and test tubing to 500#. Held okay. Fished standing valve and ran new pump. Hung well on. Return to production.

5-27-13 MI&RU. Unseat pump and POH. Pump hot water down tubing. Drop standing valve and tested (did not hold). Found split tubing joint. Tested tubing to 2500#, held okay. Replaced split joint tubing and RIH with pump. Set 77 joints 2-3/8" tubing at 2200'.
