- Identification Problem No. 1 Downed Well Sign: Per discussions between Mr. Harley Davis, Natural Resource Specialist at the Roswell Field Office, and Chris Smith, Field Foreman, Scythian, Ltd., our request to leave the signs near each wellhead was granted. (September 25, 2013)
