

Mixed @ 14.8#/g w/1.33 yd. Plug down @ 2:30 PM 11/15/13. Test BOPE to 3000# & annular to 1500#. At 2:30 P.M. 11/16/13, tested csg to 1500# for 30 minutes, held OK. Circ 129 sks of cement to pit.






