

Concho respectfully requests approval to spot a cement kick-off plug and sidetrack around a 5-1/2" 17 ppf casing fish in the Cadillac State #4. TD of 5432' was reached on 1-28-2014. While running 5-1/2" casing on 1-29-2014, the casing stuck with the bottom at 5203'. Fishing operations were begun and have been continuous since. The casing has been recovered to a top of fish at 3746', but efforts to recover more have been unsuccessful. Concho proposes to set a cement plug of 250 sacks from the top of fish at 3746' up to approximately 3150'. The cement plug will then be dressed off, and the well sidetracked at approximately 3500' and re-drilled vertically to the original TD.
