Location was reclaimed on four sides to final pad size of 159' x 151' and no tank battery. Reclaimed area was reseeded 05-07-13 with BLM seed mixture #2. Caliche piled on SE side of location removed and used for pad building/repair.

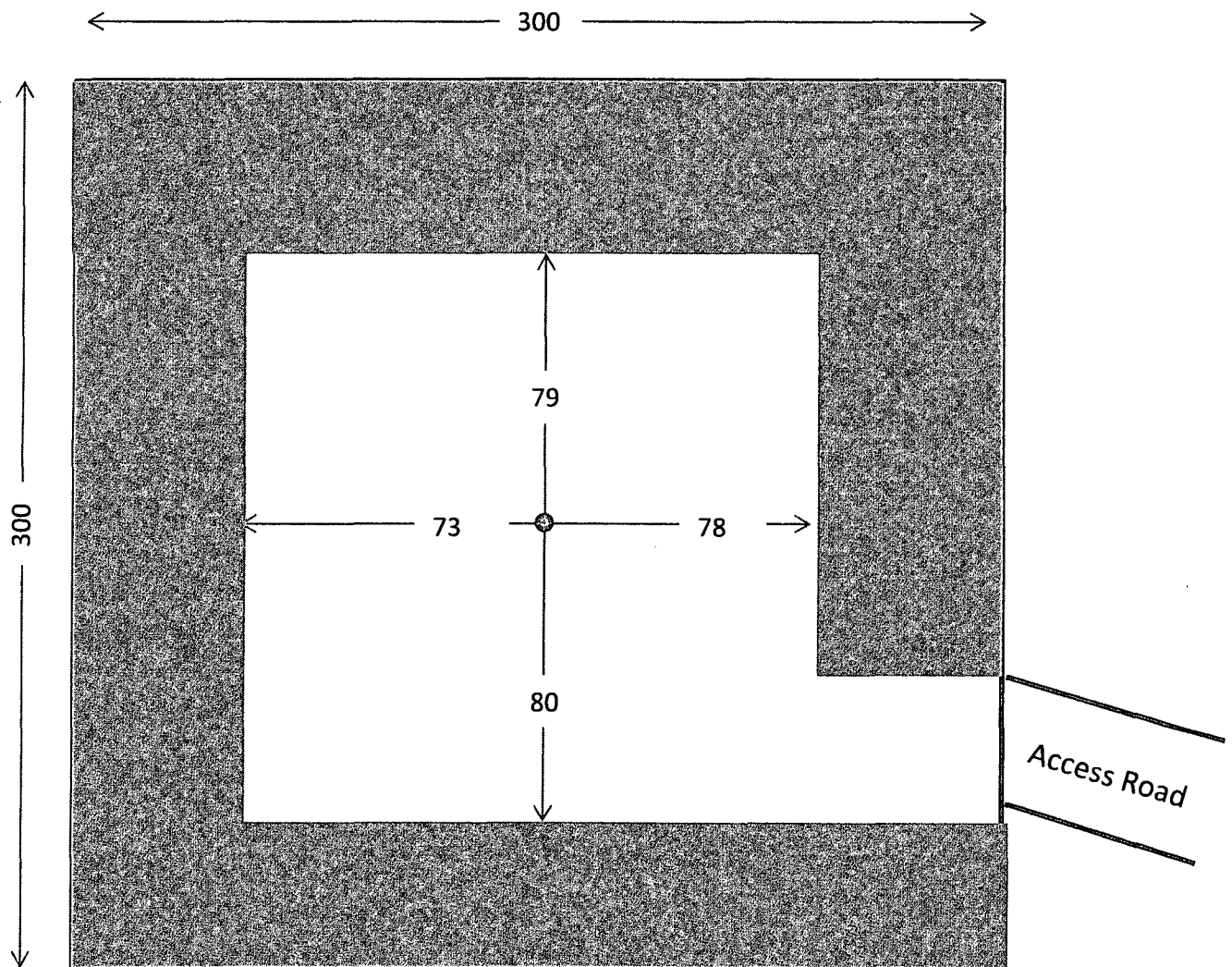
